The All-Party Parliamentary Group on Women, Peace and Security (APPG-WPS) is a forum for the discussion and analysis of issues relating to Women, Peace and Security. It brings together Parliamentarians, policy makers and civil society. Among other issues, the APPG-WPS is primarily focused on the UK Government's implementation of Women, Peace and Security commitments and work on Women and Girls rights. It promotes the vital role that women and girls play in peacebuilding, conflict resolution and post conflict reconstruction around the world and highlights the impact of violence and conflict on women and girls.
